Various of WAM's limited partners and employees are also officers and trustees of the Trust, but WAM does not consider the Trust to be controlled by such persons. Although the Trust is not controlled by WAM, pursuant to rule 13d-3(a) the 742,000 shares beneficially owned by the Trust, with respect to which the Trust has delegated to WAM shared voting power and shared dispositive power, are considered to be shares beneficially owned by WAM by reason of such delegated powers. In addition to the shares beneficially owned by the Trust, other clients of WAM may own shares which hare not included in the aggregate number of shares reported herein because WAM does not have or share voting or investment power over those shares.

At December 31, 1995, WAM did not own greater than 5% of the outstanding shares of common stock of NABI. The percentage shown in the original statement on Schedule 13G was based on an erroneous number of outstanding shares.
